To their Lordships the Chief Justice and the other Judges of the Supreme Court of the Democratic Socialist Republic of Sri Lanka.

The petition of the above named petitioners, appearing by their registered instructing attorney-at-law J.J. Rajakaruna, respectfully states as follows :-

1. THE PARTIES

The petitioners are citizens of Sri Lanka.

The 1st petitioner was at all material times a registered voter entitled to vote at the said election, and he was registered as a voter in the Kandy District. The 1st petitioner was a candidate [nominated by the United National Party] at the Provincial Council Elections for the Central Province, in the Administrative District of Kandy, held on 6th April 1999. A true copy of the voters list is annexed, marked A¹. [He was not declared elected.]

The 2nd petitioner was at all material times a registered voter entitled to vote at the said election, and he was registered as a voter in the Kandy District. A true copy of the voters' list is annexed, marked A². The 2nd petitioner is the Chairman of the Udadumbara Pradeshiya Sabha [elected on the nomination of the United National Party.] The 2nd petitioner is a member of the United National Party and has been actively involved in activities of the said Party.

The 3rd petitioner was at all material times a registered voter entitled to vote at the said election, and he was registered as a voter in the Kandy District. A true copy of the voters' List is annexed, marked A³. The 3rd petitioner is a member of the United National Party and has been actively involved in activities of the said Party. The 3rd petitioner is the Chairman of the U.N.P. Branch at Talagune.

The 4th petitioner was at all material times a registered voter entitled to vote at the said election, and he was registered as a voter in the Kandy District. A true copy of the voters' List is annexed, marked A⁴. The 4th petitioner is a member of the United National Party and has been actively involved in activities of the said Party. The 4th petitioner was appointed a U.N.P. polling agent, to function at the Kalugaloya K.V. Polling Station in the Udadumbara Electorate in the Kandy District, at the Provincial Council elections held on 6th April 1999.

The 1st respondent is the Commissioner of Elections. The 1st respondent was under a duty to conduct free and fair election in terms of the provisions of the Provincial Councils Elections Act No: 2 of 1998 as amended, in respect of the Provincial Council elections conducted for the Central Province, held on 6th April 1999. The 2nd respondent was required to perform certain statutory functions in terms of the provisions of the Provincial Councils Elections Act No: 2 of 1988 as amended.

The 3rd Respondent is the Attorney General of Sri Lanka.

The 4th to 10th Respondents are the General Secretaries / Authorised Agents of the recognised political parties which tendered valid nomination papers for the said election in the Kandy District, and whose candidates contested the said election.

The 11th Respondent is the Group Leader / Authorised Agent of the independent group which tendered valid nomination papers for the said election in the Kandy District, and whose candidates contested the said election.

The 12th to 16th respondents have been made respondents as their names transpire in the allegations hereafter made, and in order to give notice to the said respondents of the said allegations.

2. PROVINCIAL COUNCIL ELECTIONS – CENTRAL PROVINCE

The Central Provincial Council election was held and conducted under the provisions of the Constitution and in particular Chapter XVII A thereof [brought in by the 13th Amendment], and also the Provincial Councils Elections Act No 2 of 1988, as amended.

The holding and conduct of the said election is executive and administrative action, within the meaning of Articles 17 and 126 of the Constitution.

The Central Province consists of the Administrative Districts of Matale, Kandy [Mahanuwara] and Nuwara Eliya.

The term of office of the Central Provincial Council elected in 1993 expired in terms of Article 154 E of the Constitution. Accordingly, the election for the said Council [along with elections for four other Provincial Councils] was duly proclaimed. Thereafter, nomination papers were submitted, and accepted. Thereafter, the date of poll was fixed as being 28th August 1998. However, the election was not held. A true copy of the Government Gazette dated 15th July 1998 numbered 1036 / 5 is annexed marked A⁵.

Subsequently, there was an application made to the Supreme Court regarding the failure to hold Provincial Council elections. After hearing, the Supreme Court delivered its judgment, directing that the said elections for the five Provincial Councils be held.

hereinafter, the elections for the five Provincial Councils [including the Central Provincial Council] were fixed for 6th April 1999.

The Peoples' Alliance [hereinafter called PA], the United National Party [hereinafter called UNP], the National Union of Workers [hereinafter called NUW], the Janatha Vimukthi Peramuna [hereinafter called JVP], the Mahajana Eshath Peramuna [hereinafter called MEP], the Liberal Party [hereinafter called LP], the Sri Lanka Progressive Front [SLPF] and an Independent Group tendered their nomination papers for the Administrative District of Kandy. The said nomination papers were duly accepted.

The election was held on 6th April 1999.

The 1st respondent declared the results of the election. A true copy of the Results Sheet is tendered herewith, marked A⁶.

The said final results in the Central Province were as follows :-

3. INCIDENTS INSIDE THE POLLING STATIONS.

The period of several weeks prior to the election, and the day of the election too, were marred by incidents of violence and intimidation effected by supporters of



the People's Alliance against the candidates and supporters of the United National Party and other Parties, in the Kandy District.

On the 6th April 1999, during the polling hours, there were serious incidents inside several Polling Stations in the Kandy District, for which supporters of the People's Alliance were responsible. Details of several such incidents are given below.

3.1 UDADUMBARA ELECTORATE

Kalugalya K.V. - Polling Station No : 17

The affidavit of U.N.P. polling agent W.A.M. Seneviratne Banda is tendered herewith, marked A⁷. At about 8 a.m. a mob of P.A. supporters, armed with weapons, led by D.B. Ratnayake, a P.A. candidate at the said election, stormed the Polling Station, and threatened the agent, and assaulted him with the Presiding Officer's chair. The agent was wounded, sustaining a fracture in his hand and bruises on his head. He left the Polling Station. Later he was admitted to the Uda Dumbara District Hospital, and was later transferred to the Kandy General Hospital. A complaint was made to the Udadumbara Police Station.

Pamunupura K.V. - Polling Station No : 22

The affidavit of U.N.P. polling agent Y.M.W.G. Tikiribanda is tendered herewith, marked A⁸. He went to the Polling Station, together with the other U.N.P. agent R.M.Jayasinghe, at about 6.15 a.m. At about 6.50 a.m. a group of P.A. supporters requested the Presiding Officer to send the U.N.P. agents out of the Polling Station, on the pretext that the polling had not yet commenced. Although the P.A. polling agents were present, and were allowed to remain, the Presiding officer ordered the U.N.P. agents to leave. The U.N.P. agents left and were immediately threatened by a mob of P.A. supporters who were waiting outside. The U.N.P. agents were thus compelled to take shelter near by. Later, at about 9.30 a.m., the U.N.P. agents returned to the Polling Station, accompanied by U.N.P. candidate Danister Vidanagama. The said candidate recorded a complaint in the Presiding Officer's Journal.

Maha Assedduma K.V. - Polling Station No : 37

The affidavit of U.N.P. polling agent E.M. Lokubanda is tendered herewith, marked A⁹. At about 3.30 p.m. a P.A. candidate at the said election, namely R.B. Herath, accompanied by several persons in police uniform [who were armed with guns] and a mob, entered the Polling Station. They threatened U.N.P. agents, and

then threatened the Presiding Officer. Thereafter, they snatched ballots and cast them. The agent requested the Presiding Officer to record this in the Journal, and believes that this was so recorded.

Dutugemunu Co-operative - Polling Station No : 38

The affidavit of U.N.P. polling agent S.A.M. Chularatne Banda is tendered herewith, marked A¹⁰. At about 3.45 p.m. a P.A candidate at the said election, namely R.B. Herath, accompanied by several persons in police uniform [who were armed with guns] and a mob, stormed the Polling Station. They threatened U.N.P. agents, and snatched ballot books from the Presiding Officer and cast the ballots. The agent believes that this incident was recorded in the Presiding Officer's Journal.

3.2 PATADUMBARA ELECTORATE

K / Jami Ul Asher M.M.V. - Polling Station No : 12

The affidavit of U.N.P. polling agent U.L.S. Marikkar is tendered herewith, marked A¹¹. At about 6.55 a.m. two armed P.A. supporter stormed the Polling Station and threatened the U.N.P. polling agents and snatched ballot papers and stuffed the ballot box. This was recorded in the Presiding Officer's journal. A complaint was made at the Kandy Police Station.

Wattegedara K / Muslim Vidyalaya - Polling Station No : 13

The affidavit of U.N.P. polling agent W.A.J. Anton Perera is tendered herewith, marked A¹². At about 7 a.m. a mob of armed P.A. supporters stormed the Polling Station and threatened the U.N.P. polling agents, and snatched ballot papers and stuffed about 600 ballots in the ballot box. The agent complained to the Presiding Officer. The other agent made a complaint at the Kandy Police Station.

Ratnajothi K.V. - Polling Station No : 14

The affidavit of U.N.P. polling agent H.M.W. Herath is tendered herewith, marked A¹³. At about 10 a.m. a mob of about 200 armed P.A. supporters stormed the Polling Station and threatened the U.N.P. polling agents, and snatched ballot papers and stuffed about 500 ballots in the ballot box. This was recorded in the Presiding Officer's journal and in the note book of the Police Officer present on duty. A complaint was made at the Kandy Police Station.

Egodagama K.V. – Polling Station No : 16

The affidavit of U.N.P. polling agent E.H.R.V. Wijesinghe is tendered herewith, marked A¹⁴. At about 9.30 a.m. a mob of about 50 armed P.A. supporters stormed the Polling Station and threatened the U.N.P. polling agents, and snatched ballot papers and stuffed about 600 ballots in the ballot box. The other agent recorded this in the Presiding Officer's journal.

Wegodagama K.V. – Polling Station No : 17

The affidavit of U.N.P. polling agent S.G. Jossy is tendered herewith, marked A¹⁵. At about 11 a.m. a mob of about 50 armed P.A. supporters stormed the Polling Station and threatened the U.N.P. polling agents, and snatched ballot papers and stuffed about 300 ballots in the ballot box. This was recorded in the Presiding Officer's journal.

Pahala Yatawara Sri Nandarama – Polling Station No : 18

The affidavit of U.N.P. polling agent Prithi Naranpanawa is tendered herewith, marked A¹⁶. A mob of about 50 armed P.A. supporters stormed the Polling Station and threatened the U.N.P. polling agents, and snatched ballot papers and stuffed about 900 ballots in the ballot box. This was recorded in the Presiding Officer's journal.

Aluthgama K.V. – Polling Station No : 20

The affidavit of U.N.P. polling agent W.M.S.S.M.B. Welagedera is tendered herewith, marked A¹⁷. At about 10.30 a.m. a mob of about 150 armed P.A. supporters led by Kudugala Jayaratne, a P.A. candidate at the said election, stormed the Polling Station and threatened the U.N.P. polling agents, and snatched ballot papers and stuffed about 300 ballots in the ballot box. This was recorded in the Presiding Officer's journal. A complaint was made at the Kandy Police Station.

Girakaduwa P.V. – Polling Station No : 23 – Hall No : 1

The affidavit of U.N.P. polling agent C.K.B. Dedunupitiya is tendered herewith, marked A¹³. At about 11.30 a.m. a mob of about 150 armed P.A. supporters led by Lohan Ratwatte, son of the Deputy Minister of Defence, stormed the Polling Station and threatened the U.N.P. polling agents, and snatched ballot papers and

stuffed about 300 ballots in the ballot box. This was recorded in the Presiding Officer's journal.

Olirakaduwa P.V. - Polling Station No : ²⁴~~23~~ - Hall No : 2

The affidavit of U.N.P. polling agent S.M. Jayaratne is tendered herewith, marked A¹⁹. At about 7.10 a.m. a mob of about 200 armed P.A. supporters led by Kudugala Jayaratne, a P.A. candidate at the said election, stormed the Polling Station and threatened the U.N.P. polling agents, and snatched ballot papers and stuffed about 200 ballots in the ballot box. This was recorded in the Presiding Officer's journal. A complaint at the Katugastota Police Station.

K / Bharathiya Tamil M.V.[P] - POLLING Station No : 34

The affidavit of U.N.P. polling agent L.D.U.I. Liyanage is tendered herewith, marked A²⁰. A mob of about 50 P.A. supporters stormed the Polling Station and threatened the U.N.P. polling agents, and snatched ballot papers and stuffed about 1000 ballots in the ballot box. This was recorded in the Presiding Officer's journal. A complaint at the Wattegama Police Station. The agent was treated at the Wattegama Government Hospital.

Yatiravana M.V. - Polling Station No : 31

The affidavit of U.N.P. polling agent B.G.H. Karunaratne is tendered herewith, marked A²¹. A mob of about 150 P.A. armed supporters, led by Lohan Ratwatte, the son of the Deputy Minister of Defence, stormed the Polling Station and threatened the U.N.P. polling agent, and snatched ballot papers and stuffed about 750 ballots in the ballot box. The U.N.P. agents were chased out. A complaint at the Kandy Police Station.

Mahapathana K.V. - Polling Station No : 47

The affidavit of U.N.P. polling agent P.K.D. Henry Perera is tendered herewith, marked A²². A mob of about 75 P.A. armed supporters, led by Lohan Ratwatte, the son of the Deputy Minister of Defence, stormed the Polling Station and threatened the U.N.P. polling agent, and snatched ballot papers and stuffed about 63 ballots in the ballot box. This was recorded in the Presiding Officer's journal.

Paragala - Polling Station No : 8

The affidavit of U.N.P. polling agent I.A. Aruna Priyantha is tendered herewith, marked A²⁷. While the agent was at the Polling Station, a mob of P.A. supporters threatened him. The agent then made a complaint to the Presiding Officer. A copy is also tendered, marked A²⁸. The agent then left the Polling Station. Thereafter, a large number of impersonated votes were cast by P.A. supporters.

3.5 TELDENIYA ELECTORATE

Metideniya P.V. - Polling Station No : 17

The affidavit of U.N.P. polling agent Y.R.M. Seneviratne is tendered herewith, marked A²⁹. At about 7.30 a.m. he was assaulted and threatened by a P.A. supporter. P.A. supporters began to stuff the ballot boxes. The agent made a complaint to the Presiding Officer, and left the Polling Station. A copy of the said complaint is also tendered herewith, marked A³⁰. The agent also made a complaint at the Udadumbara Police Station.

3.6 GALAGEDARA ELECTORATE

Niyangoda M.V. - Polling Station No: 37

The affidavits of U.N.P. polling agents P.M. Indraratne Bandara and P.M.S. Kandekumbura are tendered herewith, marked A³¹ and A³². A mob of P.A. supporters stormed into the Polling Station shortly after 7 a.m. threatened and assaulted the U.N.P. agents. The U.N.P. polling agents made a written complaint in the Presiding Officers Journal, and left the Polling Station. The agents also made a complaint at the Galagedara Police station. The Presiding Officer said that he was going to close the Polling Station and make a complaint to the Police and left the Polling Station. However, the Polling Station was not closed.

Galagedara Jabbar M.V. - Polling Station No : 8

The affidavit of U.N.P. polling agent M.K.M.Hassar is tendered herewith, marked A³³. From about 8.30 a.m. three groups of P.A. supporters successively threatened the U.N.P. polling agents. At about 9.05 a.m., the U.N.P. agent Hassar made a complaint to the Presiding Officer, which he believes was entered in the Journal. The agents then left the Polling Station. Hassar has learned that the other U.N.P. agent I.L.M.Ismy had also made a complaint to the Presiding officer.

Polwatte K.V. - Polling Station No : 19

The affidavit of U.N.P. polling agent T.H.Jayasena is tendered herewith, marked A³⁴. at about 12.30 p.m. a mob of P.A. supporters stormed the Polling Station, and began to stuff the ballot boxes. The Presiding Officer thereupon closed the Polling Station, and sealed the ballot box and dispatched it at about 12.30 a.m.

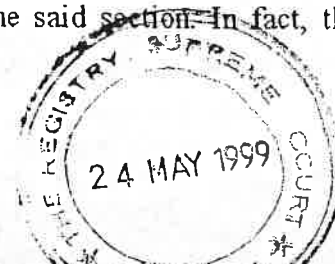
4. **NON-COMPLIANCE WITH THE PROVINCIAL COUNCIL ELECTIONS ACT AS AMENDED**

The petitioner respectfully states that in the circumstances aforesaid, it was the duty of each Presiding Officer of the relevant Polling Station to act in terms of sections 31 to 46 of the Provincial Councils Elections Act, and to keep order in the polling station, and to make it possible for the polling agents to function freely, and to ensure that ballots were issued properly and to ensure that only persons entitled to vote were allowed to cast votes.

The petitioners respectfully states that in the circumstances aforesaid, it was also the duty of each Presiding Officer of the relevant Polling Station to forthwith inform the 2nd respondent Returning Officer of the incidents mentioned above, and it was the duty of the 2nd respondent to then inform the 1st respondent Commissioner of Elections, in terms of section 46 A [1] of the Provincial Councils Elections act, as amended by Act No 35 of 1988.

Upon receiving such information, it was the duty of the 1st respondent to ascertain the truth of the information, and to declare the poll at such Polling Station void, in terms of the same section.

The Presiding Officers and / or the 2nd respondent and / or the 1st respondent have failed to comply with their duties under the said section. In fact, the purported



ballots of all the above mentioned Polling stations have been taken into account, in declaring the final results.

The petitioners respectfully state that if the poll was properly conducted at the said Polling Stations, and the votes cast were counted, the final results for the District of Kandy would have been affected.

Without prejudice to the fore going, the petitioner respectfully states that in the circumstances aforesaid, the Presiding Officers of the above mentioned Polling Stations have failed to comply with their duties under sections 31 to 46 of the Provincial Councils Elections act as amended.

5. VIOLATION OF FUNDAMENTAL RIGHTS

In the circumstances aforesaid, the petitioners respectfully states, that the conduct of the polling at the Polling Stations specified above was **not free and fair** as required by law; the petitioners' **sovereign right of the franchise**, and also that of the other voters in the said Province was denied by this fact. Also, the petitioners' **fundamental right to the equal protection of the law** as guaranteed by Article 12 [1] of the Constitution has been violated and/or denied. Also, the petitioners' **fundamental right of freedom of expression** as guaranteed by Article 14 [1] [a] of the Constitution has been violated and/or denied. Also, the petitioners' **fundamental right of freedom of association** as guaranteed by Article 14 [1] [c] and 14 [1] [g] of the Constitution has been violated and/or denied.

6. FAILURE TO COMPLY WITH ASSURANCE GIVEN TO SUPREME COURT IN EARLIER CASE

In a recent case, S.C.F.R. 265 / 99, the Commissioner of Elections [and the Inspector General of Police] assured the Supreme Court that they had taken several measures to ensure that the forth coming Provincial Council Elections would be conducted properly. They went to the extent of tendering to Court a large number of documents, which consisted of instructions they had given to their subordinates, regarding the various steps to be taken, and precautions to be observed.

True copies of some of these documents are tendered herewith, marked A³⁵.

Daya Pelpola, Secretary - Legal of the U.N.P., sent a letter dated 31st March, 1999 to the Inspector General of Police, with a copy to the Commissioner of Elections, pointing out that the above assurances given to the Supreme Court were being violated. A copy is annexed marked A³⁶.

It is seen that the relevant instructions set out in these documents have been ignored or violated, in respect of the incidents described above.

7. The petitioners have not previously invoked the jurisdiction of this Court in this matter.

8. The petitioners have not been able to obtain certain affidavits and documents. The petitioners respectfully seek the permission of this Court to tender the same. The petitioners also respectfully seek an order from this Court directing the 1st respondent to deliver, to the Registrar of this Court, the Presiding Officers' Journals pertaining to the above-mentioned Polling Stations.

WHEREFORE the petitioners humbly pray :-

- a) / for leave to proceed with this application;
- b) / for permission to tender further affidavits and documents;
- c) / for an order directing the 1st respondent to deliver, to the Registrar of this Court, the Presiding Officers' Journals pertaining to the above-mentioned Polling Stations.
- d] for a declaration that the petitioners' sovereign right of franchise under Article 4 [e] of the Constitution has been denied and / or violated, in respect of the conduct of the poll at the Polling Stations specified above;
- e] for a declaration that the fundamental rights of the petitioners guaranteed by Article 12 [1] of the Constitution [right to equality] and / or Article 14 [1] [a] of the Constitution [freedom of expression] and / or Article 14 [1] [c] and / or 14 [1] [g] of the Constitution [freedom of association] have been denied and / or violated, by reason of the failure of the 1st Respondent [Commissioner of Elections] and / or the 2nd Respondent [Returning Officer] to conduct and / or cause to be conducted a proper poll at the Polling Stations specified above;

- g] for an order directing the 1st Respondent [Commissioner of Elections] to declare void the poll at the Polling Stations specified above, and to appoint a fresh date for the taking of such poll at such Polling Stations;
- h] for costs; and
- l] for such other and further relief as to the Court shall seem just and equitable.
